**DECLARATION by AFFIDAVIT**

I, myself.....

solemnly declare the following to the best of my knowledge and full will:

01. That I agree to abide by the Rules and Regulations of **SBSP / CESTI** from time to time.
02. That I, myself, have applied for the course.....of **SBSP / CESTI** at my own will and wish.
03. That I have gone through the Prospectus / Broucher/ Website of **SBSP / CESTI** and I have decided to apply for the **above Course of SBSP / CESTI**.

**I found the following facts:**

04. that **SBSP** (SARVA BHARATIYA SHIKSHA PEETH-All India Council for Education, Training & Research) is an Independent Organization, struggling for **Total Literacy** in India since 1947, and which is being administered since 2001 by **CESTI** (COUNCIL FOR ERADICATION OF SCIENTIFIC & TECHNICAL ILLITERACY), an autonomous body, Registered under appropriate Government Act.
05. The term "**Autonomous body**" denotes a self governing body, independent, or subject to its own laws. If autonomous body or institution is a company, it is regulated by the company law. If it is a society, it is governed by the law on registration of societies. But in both the cases, its own board of directors can specify the rules of business for the body / institution. For simplicity sake, normally the boards of such bodies or institutions may adopt the rules of the concerned Government or department under which they work, but only by passing of a resolution to that effect and that since it is an autonomous body, administration of which is not controlled by any other authority including any State Govt./ Union Govt. of India, (U.G.I.)
06. **SBSP / CESTI** offers its own PROGRAMS in various areas for improving the rate of Literacy especially in the fields of Science & Technology and as well as Proficiency and Development in Entrepreneurship among the students and so all its programs are meant for **Value Addition**.
07. **SBSP / CESTI** awards its **own Certificates**, after successful completion of the course of study concerned at its "Associate Training Colleges" and passed such Examinations at the "Examination & Evaluation Centers" under the norms prescribed from time to time by the Governing Council of **SBSP / CESTI**.
08. **SBSP / CESTI** is not a University and so it does not come under the purview of the UGC / AICTE / AIU / DEC/ other Acts and hence, any of such Authorities can not recognize **SBSP**.
09. **SBSP / CESTI** programs are especially aimed to improve employability in Private Sector organizations, However, these programs may be recognized by other Sectors also for either Employment or Higher Education in India and Abroad.
10. **SBSP / CESTI** is a legal Institution under the provisions of the Constitution of India.
11. **SBSP** is a Buddhist Minority Institution, and as such, it has absolute freedom to run its activities at its own choice for the welfare of the Minorities under Article 30 of the Constitution of India.
12. **SBSP** is an Independent, un-aided, private educational institution having the right to impart education and conduct its own examinations as per the byelaws and resolutions, passed from time to time by **CESTI**.
13. **SBSP / CESTI** does not give guarantee for higher studies and employment on the strength of Certificates awarded by it.
14. **SBSP/ CESTI** neither depict nor declare that the Certificates awarded by it are equivalent to other Certificates that are issued by other Universities/ Boards/ Institutions/ etc.

15. **SBSP / CESTI** reserves its right to alter, modify, and delete any of the terms & conditions including Fee Structure, Examination & Evaluation Procedure etc at any point of time.
16. **SBSP / CESTI** reserves the right to drop any Training Program on account of Administrative and other constraints or due to non availability of required strength of students.
17. If the Student is dropped in the middle of the Program, the fees paid by the student will not be refunded or readjusted, as such he cannot claim for the same
